Registration

Registration is only possible online at www.cycling-paradise.com. From there you will be directed to the registration portal (ticket shop) of our ticket provider Eventix. Please bring the ticket purchased here with you to the accreditation in digital or printed form.

The entry fee is 99,- EUR per person, including ticket fee and VAT.
The starting places are limited to 500 participants.

The registration is binding, a refund of the entry fee is not possible.

With your registration you confirm that you have taken note of and accept this notice of race, the general terms and conditions for participants and the regulations.

At the accreditation you will receive all the necessary starting documents and participant information upon presentation of your registration confirmation (ticket) and your identity card.

Underage participants must have their legal representative sign a consent form at the accreditation. In this case, the legal representative and the underage participant must each present an ID.

Regulations & Classifications

The Cycling Paradise Sylt 2023 will be held according to the provisions of this notice of race, the GTC-participants and the applicable regulations of the Cycling Paradise Sylt 2023. This notice of race, the GTC-participants and the applicable regulations are published on www.cycling-paradise.com. With the registration the participant accepts all regulations.

We recommend that you familiarise yourself thoroughly with the above-mentioned regulations in good time. The rules and regulations mentioned in this announcement are only a rough extract. The complete and detailed rules and regulations are reserved for the GTC-participants and the regulations.

In brief:

All persons who are at least 18 years old on the day of the event (adults) are entitled to participate. Minors (under 18 years of age) require a written declaration of consent from a legal representative, which must be provided in person by the legal representative at the accreditation on site and upon presentation of his or her valid ID.

Each participant is obliged to assess his or her own health requirements for participation in the ride, if necessary, after consulting a doctor. At the request of the organiser, these must be proven by means of a medical certificate.

Bicycles made of steel before 1990 are permitted.

Helmets are not compulsory, but the organiser expressly recommends wearing a bicycle helmet.

The Road Traffic Regulations (StVO) apply without exception.

Mainly shared footpaths and cycle paths are used, sometimes also roads. The paths on Sylt are often narrow and heavily frequented. Speed must be adjusted accordingly and consideration must be shown to other road users. A bell is a prerequisite for participation. The right-hand driving rule applies.

There are no special regulations regarding clothing if it does not pose a safety risk. However, we expressly welcome you to dress in clothes from the good old cycling days, according to the motto 'vintage inspired' (e.g. 20s-30s, tweed, ...).

No time will be measured and no rankings (e.g., placings, rankings, etc.) will be made. Please adjust your maximum speed according to the given circumstances so that you do not disturb, hinder, or endanger other road users.

The start will take place between 07:30 and 09:30 in several starting blocks. You will be assigned to a starting block at the accreditation.

Should you be forced to interrupt or end the ride due to a breakdown, defect, physical complaints, or other reasons, you can get help from the guides and/or have the broom wagon bring you back to the start/finish area.

The instructions of our staff, such as the marshals, the guides, the staff at the refreshment stations, etc., must be followed immediately and without fail.

Please help us to keep the impact on the environment as low as possible and dispose of your waste only at the refreshment stations and on the event site in the containers provided.

The road surfaces vary between paved and unpaved sections and include gravel roads and cobblestone passages.

The complete overview of the rules and regulations can be found in the "General Terms and Conditions for Participants" and in the "regulations". Both documents are included in this pdf.

Regulations Cycling Paradise Sylt 2023

24.01.23

1. Basics

- 1.1. These regulations apply to the Cycling Paradise Sylt 2023.
- 1.2. With the registration at Cycling Paradise Sylt 2023 every participant accepts these regulations.
- 1.3. Each participant is obliged to familiarize himself/herself intensively with the participant information handed out at the time of accreditation and to follow its contents.

2. Participant requirements

- 2.1. All persons who are at least 18 years old on the day of the event (adults) are entitled to participate.
Minors (under 18 years of age) require a written declaration of consent from a legal representative, which must be provided in person by the legal representative at the accreditation on site and upon presentation of his/her valid ID.
- 2.2. A Membership of a cycling club is not required.
- 2.3. Each participant must accept the "General Terms and Conditions for Participants", the "Cycling Paradise Sylt 2023 Regulations" (this document), the "Cycling Paradise Sylt 2023 Notice of Race" and, in the case of accreditation, the Participant Information and follow their contents.
- 2.4. Each participant is obliged to assess his or her own health requirements for participation in the ride, if necessary, after consulting a doctor. At the request of the organizer, these must be proven by a medical certificate.

3. Bike & Accessories

- 3.1. Bicycles made of steel before 1990 are permitted.
- 3.2. Not permitted are
 - 3.2.1. click-pedals
 - 3.2.2. Brake-shift lever combinations
 - 3.2.3. disc wheels
 - 3.2.4. Attachments that pose a safety risk
- 3.3. Each participant is obliged to ensure that the equipment (bicycle & accessories) is in perfect condition and roadworthy and approved within the framework of the Road Traffic Regulations (StVO).
- 3.4. Each participant is responsible for the roadworthiness of his/her equipment. In particular, the function of all safety-relevant components must be guaranteed.
- 3.5. Participants who are found to be using unauthorized equipment after the start may be disqualified by the organizer.

4. Helm obligation, bell obligation, clothing, bib number, frame number

- 4.1. According to the StVO, helmets are not compulsory. However, the organizer expressly recommends that participants wear a helmet. For the highest possible protection, the helmet should comply with the currently valid and recognized safety regulations.

- 4.2. As the event takes place on public roads, a bell on the bicycle is a prerequisite for participation.
 - 4.3. There are no specific rules for the type of clothing, but it must not pose a safety risk. The organizer explicitly welcomes participants to dress in clothes from the good old cycling times (e.g. 20s-30s, tweed, ...) and follow the motto 'Vintage Inspired'. In addition, the organizer recommends choosing clothing according to the weather conditions so that it protects in low temperatures, wind and rain or sun.
 - 4.4. The bib number is to be attached to the back, the frame number in the frame.
 - 4.5. A transfer of the bib number to another participant is not permitted. Bib numbers can only be transferred to a substitute participant within the framework of a start place exchange via the organizer.
5. Accreditation, starting documents, stamp card
 - 5.1. Accreditation will take place on 01.09.2023 between 15:00 and 21:00 and on Saturday, 02.09.2023 between 07:00 and 09:30 on the event grounds at kursaal3 (kursaal3, Strandstraße 25, 25996 Wenningstedt-Braderup / Sylt).
 - 5.2. Upon presentation of the registration confirmation (valid ticket with name) and in connection with a correspondingly valid photo ID, the participant will receive the starting documents at the accreditation on site.
 - 5.3. Each participant will receive a stamp card with the starting documents. This must be stamped at the refreshment stations and serves as proof of completion of the course and the associated participant medal. The last stamp station is in the finish area.
6. Timekeeping & classifications

Cycling Paradise Sylt 2023 is a bike ride within the framework of the applicable traffic regulations according to the German road traffic regulations: StVO. No rankings will be kept, no timekeeping will be carried out and no classifications will be awarded as part of this event.
7. Start block allocation

Each participant will be informed of his/her individual starting block allocation and starting time at the accreditation based on the starting number handed out to him/her. Each participant must start from the starting block and start time assigned to him/her. This allocation can no longer be changed.
8. Start time and -location
 - 8.1. The start will be at the event area in Wenningstedt (kursaal3, Strandstraße 25, 25996 Wenningstedt-Braderup / Sylt), on the beach promenade, transition into Strandstraße.
 - 8.2. The start will be in several start blocks, between 07:30 and 09:30 a.m.
 - 8.3. Each participant is obliged to be in his starting block at least 10 minutes before his starting time. There is no order within a starting block.
9. Refreshment stations during the ride
 - 9.1. Several refreshment stations are set up at Cycling Paradise Sylt 2023.
 - 9.2. Participants can find the exact positioning of the refreshment stations in the starting documents.

10. Discontinuation or abandonment

If a participant is forced to interrupt or end the ride due to breakdown, defect, physical discomfort, etc., he/she can inform our guides and indicate that he/she needs help. Alternatively, he can ask for help at the refreshment stations or ride back to the event site independently using public transport.

11. Escort vehicles and broom wagons

11.1. The organizer will accompany the ride with its own guides on racing bikes. The guides have the task to be a contact point for participants and to help. They have direct contact with the organizer via mobile, can request paramedics and/or inform the broom wagon. In addition, the guides have a basic equipment of tools, drinks and first aid kit with them.

11.2. The organizer provides a van that serves as a broom wagon and can bring participants who must abandon their ride back to the event site.

11.3. Without exception, it is prohibited for personal or group vehicles to accompany the participants.

12. Minimum speed, maximum speed cut-off time

12.1. No minimum speeds are required at Cycling Paradise Sylt 2023.

12.2. The maximum speed must be adapted to the given circumstances in such a way that no other road users are endangered or hindered.

12.3. The refreshment stations will be closed after our guide at the very end has passed.

12.4. Cut-off time at the finish in Wenningstedt is 17:00. All participants must have reached the finish by then.

12.5. Participants who are no longer able to reach the finish within the required time or who must abandon their participation in the ride for other reasons will be transported to the event site by the broom wagon upon request. For this purpose, the participant is obliged to draw the attention of the guides, staff at the refreshment stations, the course marshals, or the broom wagon to him/herself and to demand an appropriate lift.

12.6. Participants who want to finish the ride beyond the time limit and are overtaken by the broom wagon will then continue their ride outside the applicable Cycling Paradise Sylt 2023 regulations and at their own risk.

12.7. Should the traffic situation require it, the organizer is authorized, in accordance with the police and regulatory authorities, to cancel all or part of the ride for all or individual participants.

12.8. The instructions of the guides and staff of the broom wagon, as well as the course marshals, must be followed unconditionally and immediately.

13. General riding regulations

13.1. Cycling Paradise Sylt 2023 will be held in public road traffic on predominantly shared footpaths and cycle paths, on roads that are not closed off and on dirt tracks. The German Road Traffic Regulations (StVO) apply without exception.

13.2. The participants must adhere to the regulations of the StVO, in particular to the right-hand driving rule, to a prudent and considerate behaviour towards other road users, in particular when overtaking a vehicle in front, to the stopping rule at traffic

lights and to the stopping ban at railroad crossings, as soon as the red light comes on.

- 13.3. The paths and roads used on Sylt are often narrow and at the same time very busy. Adjust your speed accordingly and show consideration for other road users. Oncoming traffic must be always expected.
- 13.4. The road surfaces vary between paved and unpaved sections and include gravel roads and cobblestone passages.
- 13.5. Throwing away waste, drinking bottles or other objects of any kind and nature is prohibited. Violation of this regulation will result in immediate exclusion from the event and may be punished by the organiser. Each participant is obliged to dispose of his/her waste exclusively at the refreshment stations or at the finish, on the event grounds.
- 13.6. The organizer recommends that participants carry at least one spare inner tube, puncture repair kit and an air pump.
- 13.7. When repairing a defect (e.g., changing a tube), the participant must ensure that road users (cyclists, pedestrians, cars, ...) are not obstructed.

14. Finish

- 14.1. The finish is at the event area in Wenningstedt (kursaal3, Strandstraße 25, 25996 Wenningstedt-Braderup / Sylt), crossing Strandstraße, Strandpromenade.
- 14.2. After crossing the finish line, the finish area must be left quickly to avoid backups on the road.

15. Participant medal

Every participant who presents the stamp card completely stamped will receive a medal, which will be handed over immediately after arrival.

16. Sanctions and penalties

- 16.1. The organizer is authorized to impose appropriate sanctions in the event of breaches of the rules. This serves the smooth and safe running of the ride and the safety of all participants and road users.
- 16.2. The penalty is at the discretion of the organizer.

**General Terms and Conditions
for participants of the cycling tour
Cycling Paradise Sylt 2023
(Participants-GTC)**

1. Validity of the general terms and conditions participants, terminology

- 1.1 The Cycling Paradise Sylt 2023 (Event) is a vintage bike event, consisting of a central event area in and at the Kursaal³ in Wenningstedt/Sylt (Event Area) and a bike ride (Ride), with vintage bikes (pre-1990 steel bikes) in public road traffic along a signposted route across the island of Sylt, including refreshment stations (Route).
- 1.2 The Participants-GTC apply between the holder of a registration confirmation (Participant) and the Organizer, CYCLING PARADISE GmbH (Organizer). The GTC-Participants apply on the event site, on the route and during the entire ride.

2. Requirements

- 2.1. All persons who are at least 18 years old on the day of the event (adults) are entitled to participate. Minors (under 18 years of age) require a written declaration of consent from a legal representative, which must be given in person by the legal representative at the accreditation on site and upon presentation of his/her valid identification.
- 2.2. Prerequisite for participation in the ride is a proper registration (ticket) via the ticket shop (ticket purchase) on www.cycling-paradise.com. This includes the complete and truthful filling in of the participant data, the acceptance of these "Participants-GTC", the "Notice of Race of Cycling Paradise Sylt 2023" (Notice of Race) and the "Regulations Cycling Paradise Sylt 2023" (Regulations) as well as the complete payment of the ticket price and all applicable fees.
- 2.3. The entitlement to start (receipt of starting documents incl. official start number) requires proper accreditation on site. Accreditation can only take place with a valid ticket bearing a name and in conjunction with a correspondingly valid photo ID.

3. Obligations

- 3.1. By registering, the participant expressly acknowledges the rights and obligations of these Participants-GTC, the notice of race and the regulations. These are available and can be viewed at any time on the Organizer's homepage at www.cycling-paradise.com and in this pdf-document.
- 3.2. With the accreditation on site, the participant expressly accepts the participant information handed out to him/her (incl. hygiene and infection protection measures) and the house rules.
- 3.3. Each participant is obliged to assess his or her own health conditions for participation in the ride, if necessary, after consulting a doctor.
- 3.4. Each participant is obliged to ensure that his or her equipment is in perfect condition and roadworthy.
- 3.5. Each participant is obliged to follow the instructions in the notice of race, the rules in the regulations as well as the instructions of the staff and assistants before, during and after the ride. Failure to do so may result in the participant concerned being excluded from the event by the Organizer.

4. Conclusion of the contract

- 4.1. The registration constitutes a binding contractual offer by the participant to the Organizer and is exclusively possible online via the ticket shop at www.cycling-paradise.com. Registrations by email, post or fax cannot be accepted.
- 4.2. Each participant is obliged to state his/her correct and complete name and date of birth upon registration.
- 4.3. After receipt of the entry fee by the Organizer, the participant will receive an official registration confirmation (ticket) by email, with which the participation contract comes into effect.

5. Tickets, Resale ban

- 5.1. The tickets for the event are sold by the Organizer via the ticket service provider EVENTIX. The purchase of tickets is subject to the General Terms and Conditions of EVENTIX B.V., which can be accessed and viewed at any time at www.eventix.io.
- 5.2. With the successful registration, the participant acquires a personalized right to participate, which applies exclusively to the ticket holder in whose name this ticket was purchased and whose name is entered in the designated field on the ticket.
- 5.3. The purchase and resale of tickets for commercial purposes is not permitted.
- 5.4. The tickets remain the property of the Organizer until payment has been made in full.
- 5.5. If the ticket is lost, it will not be replaced.
- 5.6. The tickets are digital tickets and will be sent to the participant digitally by email.
- 5.7. Each participant can only register once per event. In the event of multiple registrations by one and the same person, these will only be counted once; there is no entitlement to a second or more starting places.

6. Order of Goods

- 6.1. If the participant orders goods as an additional service when registering, the General Terms and Conditions applicable to orders of goods shall apply.

7. Payment

- 7.1. Participants can pay by instant bank transfer, by PayPal or by credit card (VISA or Master Card).
- 7.2. If the amount is not redeemed or charged back (cancellation) due to lack of funds in the account or revocation by the participant, the Organizer is entitled to withdraw from the contract without setting a further deadline and to charge the participant with the costs of the withdrawal. The bank charges incurred by a return debit note shall be borne by the participant.

8. Registration

- 8.1. Only on presentation of the ticket (printed or digital) and on presentation of their identity card/passport will the participant receive their starting documents at the accreditation on site. The starting documents cannot be sent by post.
- 8.2. Each participant is obliged to check his/her starting documents for completeness immediately after receipt. Later complaints cannot be considered.
- 8.3. In application of §108 para. 1 BGB (German Civil Code), underage participants must provide consent through their legal representative at the time of accreditation. This

consent must be given by the legal representative in person on site and upon presentation of his/her valid identification.

9. COVID-19-Pandemic

- 9.1. On the day of the event and on the day of accreditation, the official health and safety regulations for the control of the coronavirus of the Federal Government, the State of Schleswig-Holstein and the additional measures extended by the Organizer at its own discretion shall apply to the participant. Changes at short notice are possible.
- 9.2. To fulfil possible official participation requirements for participation in events, the participant undertakes to fulfil these requirements (e.g., PCR entry or exit testing, rapid antigen test, etc.) at his/her own expense and for his/her own account.
- 9.3. The participant agrees to provide the Organizer with a possibly necessary digital or analogue medical history sheet on his/her own state of health, insofar as this is required by public law regulations.
- 9.4. The Participant agrees to provide digital or analogue information, if necessary via an automated data comparison, on vaccination and/or test status.
- 9.5. The risk of exposure to coronavirus exists in any public place where people are present. COVID-19 is characterized by rapid transmission of the coronavirus with a high risk of infection, which can lead to various diseases and symptoms, including permanent damage and death. According to the government's disease surveillance and prevention agencies and the World Health Organization, older people and those with pre-existing conditions are particularly at risk. By registering to participate, participants voluntarily assume all risks related to infection in the COVID-19 pandemic. For the safety of all participants, each participant undertakes to provide such data whose processing is required by public law regulations to combat the COVID-19 pandemic, e.g., a declaration of his/her contacts in relation to persons infected with COVID-19.

10. Withdrawal / Change of distance / substitute participant

- 10.1. A right of withdrawal is excluded. A refund of the ticket service fees is excluded in any case.
- 10.2. After receipt of the official confirmation of registration, the participant may nominate a substitute participant up to and including 02 August 2023 (re-registration of the ticket and transfer of the right to participate to a third party). A re-registration fee of € 15.00 will be charged for each substitute participant, which is to be borne by the original participant. The General Terms and Conditions for Participants and all other contractual obligations between the participant and the Organizer with regard to the event shall also apply to the substitute participant, in particular the notice of race, the regulations and the participant information handed out upon accreditation shall be observed by the substitute participant.

11. Cancellation of the event / no-show

- 11.1. Cycling Paradise Sylt 2023 will generally be held in all weather conditions. However, should weather conditions give rise to fears of danger to life, limb or health for participants, visitors, artists or staff, the event will be cancelled, aborted or interrupted. In this case, as well as in the event of the event being cancelled for other reasons of force majeure, due to official order or court decision, there shall

be no claim for reimbursement or damages, unless the Organizer can be blamed for a fault.

- 11.2. If the event must be cancelled due to an official order because of the Covid 19 virus, clause 11.1 above shall apply accordingly. It shall also apply if the Organizer, after weighing up all the circumstances, comes to the conclusion that the event must be cancelled, in particular due to danger to life and limb of the persons or participants involved in the event, due to entry and travel restrictions or also due to contract cancellations by third parties for whom the Organizer cannot find a replacement.
- 11.3. If the event is cancelled by the Organizer through no fault of the Organizer, the participant shall have no claims for damages against the Organizer for costs or expenses incurred by the participant.
- 11.4. In the event of a no-show by the individual participant, all claims of the participant against the Organizer shall be forfeited.

12. Liability

- 12.1. Participation is at the participant's own risk. By registering, the participant expressly declares that he/she is aware of the specific dangers of a road bike ride that is carried out in public road traffic (the German Road Traffic Regulations (StVO) always apply).
- 12.2. The Organizer, its legal representatives or its vicarious agents shall only be liable in the event of intent or gross negligence.
- 12.3. The Organizer's liability for initial impossibility and for the breach of essential contractual obligations also remains unaffected by the above limitation of liability in accordance with Clause 12.2, but is limited to the foreseeable damage typical for the contract.
For cases of initial impossibility, however, the Organizer shall only be liable if he was aware of the impediment to performance or the lack of knowledge is due to gross negligence, provided that no cardinal obligation is affected thereby. Claims for damages arising from injury to life, body or health as far as under the Product Liability Act remain unaffected by the above limitation.
- 12.4. The Organizer accepts no liability for lost items of clothing, valuables and equipment belonging to participants that have not been handed over to him/her for safekeeping. They should therefore be insured accordingly.
- 12.5. Participation in the Cycling Paradise Sylt 2023 ride requires that the participant is healthy, in good physical condition and therefore able to take part in the event. The participant is responsible for ensuring that these requirements are met. The Organizer assumes no liability for health risks of the participants. Upon receipt of the start number, the participant bindingly declares that there are no health concerns against his/her participation.
- 12.6. In the event of changes to the event (route, program, etc.), the participant has no claims against the Organizer, as long as changes remain within a certain framework and the overall character of the event is maintained.
- 12.7. The Organizer is not liable for service disruptions in connection with services that are merely arranged as external services, and which are expressly identified as external services in the specific service description.
- 12.8. The above exclusions and limitations of liability also apply to the liability of the Organizer for its organs, employees and vicarious agents and for the personal liability of its organs, employees and vicarious agents.

13. Data collection and utilization

- 13.1. The personal data provided by the participant during registration will be stored and processed only for the purpose of carrying out and managing the event.
- 13.2.
